EASY PAYROLL DEDUCTION

A. Amount per pay period

\$6 per pay period (26 pay periods) This contribution could, for example, provide for a home bound person to maintain self-sufficiency and receive a hot meal at home 5 days a week for a month OR a teeth cleaning and dental exam for 3 uninsured adults. This qualifies you for membership in the Caring Club (see back for details)

\$8 per pay period (26 pay periods) This contribution could, for example, provide for over one year of quality after school programming for a student from a low income family OR Carelink Emergency Response service to a frail elder for 8 months.

\$12 per pay period (26 pay periods) This contribution could, for example, provide 5 hours of court advocacy for survivors of domestic violence, OR provide one working family on the verge of homelessness the opportunity to remain in their home by providing emergency rental assistance for one month, helping to also keep their utilities on, their children in daycare and remain working.
